SUHF

General Assembly

- VC:s and Directors of administration of all members
- Formal decision meetings twice a year
- Voting powers according to revenue size (if needed)
- Extra meetings (information sharing) when needed
- Decides statutes, members, fees, board members, strategic documents





Board and presidium

- **Board (7 VCs, 1 director of administration, 1 adjunct student representative) – 8 times a year, Astrid Söderbergh Widding, Stockholm university, chair and Hans Adolfsson, Umeå university, vice chair**
- **Decides expert groups/standing committees, task-and-finish groups, the SG, formal responses to the government and other authorities, prepares the GA meetings**
- **Presidium (chair, vice chair and secretary general) – every week**
- **Decides nominations/appointments of representatives/experts, prepares board meetings, extensive dialogues with stakeholders**

Working modus (25-30 groups)

- standing committees (with sub-committees)
- chaired by a VC, other university leaders and experts
- coordinates their area of responsibility, dialogue with stakeholders, prepares recommendations, organise peer-learning activities
- Task-and-finish groups



Outcomes

- Support to the members through recommendations, frameworks, green/white papers, workshops, conferences (30/y)
- Advocating the members opinions/needs to the government, authorities, industry, trade unions, and other relevant stakeholders
